**Important Notes :** 1. The total number of section of the school shall be restricted to 15 (As per prescribed dimension) as per the number of class rooms reported by the school on the mandatory disclosure link and further

increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.

2. The school is required to put up the name board at the entrance of the school according to the NOC and submit the compliance within 3 months on SARAS portal.

3. The school is required to set up Maths lab separately as per board norms and submit the compliance within 3 months on SARAS portal. The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities and upload compliance on SARAS portal within 3 months.

4. The ramps constructed by the school at the entrance and to access the upper floors are not as per norms. Ramps have been overlaid on the existing steps which makes them very steep, posing a danger to student safety. The school shall tear them down and re-construct the same as per specifications of RPwD Act, under the supervision of qualified architect and submit compliance on SARAS, within 3 months. Similarly the school shall provide for separate toilets for CWSN, boys and girls on every floor, as per specifications of RPwD Act and submit compliance.

5. The school shall ensure the training of its teachers with CoE Ajmer within the next 3 months and upload compliance on SARAS.

6. The school is required to renew all the mandatory certificates from time to time and directed not to remove videography link in future.
